The Fertiliser Association of India (FAI) is a Non-Profit, Non-Trading organization registered under Section-8 of Companies Act 2013. The FAI is also a premier body representing the fertilizer industry in India. The FAI was founded in 1955 with the objective of bringing together all concerned in the production, marketing and use of fertilizers. The FAI is engaged in promoting solutions to industry problems, to assist industry in improving its operative efficiency and to promote the use of balanced fertilizers for raising agricultural productivity. With nearly 1000 members, FAI is managed by a Board of Directors comprising around 32 Directors who are mostly Chairman & Managing Directors (CMDs)/ Chief Executive Officers (CEOs)/Directors of member companies.

The FAI interacts extensively with the Government of India; International bodies such as the Food & Agriculture Organization (FAO), World Bank, United Nations Industrial Development Organization and the International Fertilizer Association; and is engaged in developmental activities to further the cause of the Fertilizer Industry and Sustainable Agriculture.

Applications are invited for the post of Director General (DG) to lead the Secretariat of the Association. DG is an Ex-officio member of the FAI Board.

The Director General will play a critical role in managing the interface with external agencies, other Industry Associations and the Media. He will work closely with the Government for fostering the health and growth of the Fertilizer Industry keeping the farmers' interests in mind. He will also spearhead all advocacy issues and developmental activities of the Association.
