**FAI Webinar on "Inspection and Maintenance of Compressors and Turbines in Fertilizer Plants", 25<sup>th</sup> August 2021, 0930 to 1630 hrs.**

Compressors and turbines are capital intensive equipment and are critical for reliable and efficient operation of fertilizer plants. The major compressors and turbines include process air, ammonia, synthesis, refrigeration and carbon di oxide compressors in ammonia - urea plants. A large number of fertilizer plants have also installed gas turbines with heat recovery steam generation system for power generation or as drive for air compressor. Most of the fertilizer plants are vintage plants. For improving the efficiency and reliability, a number of plants have retrofitted and refurbished the old compressors and turbines. Some plants have replaced the old machines with more efficient ones. Continuous monitoring and inspection even during operation are required to ensure health of these critical machines. Over the years, there have been changes in the design and operation and maintenance practices of these machines. Continuous update of knowledge and keeping abreast of the latest developments are part of professional development which help engineers to perform their duties with a high competence.

It is in this context, FAI is organizing a one-day Webinar on "Inspection and Maintenance of Compressors and Turbines in Fertilizer Plants" on 25<sup>th</sup> August 2021 during 0930 to 1630 hrs. The Webinar will include lectures and presentations from experts from fertilizer industry and leading vendors. Case studies on recent modifications/maintenance of compressors and turbines will also be included. A list of topics is attached.
