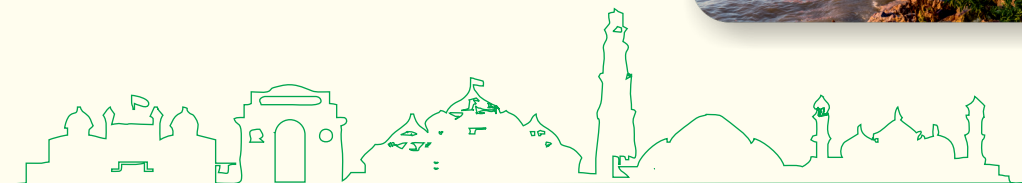
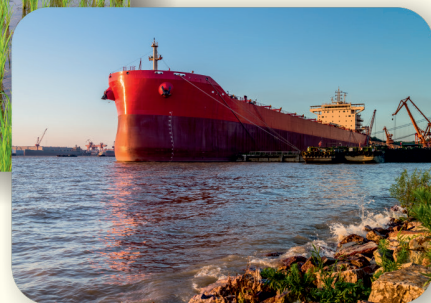

□ From the DG's Desk

Dear Friends,



India has solidified its position as the fastest-growing economy in the world and its economy enters in 2026-27 on a strong footing. Agriculture is the vital sector of the economy and use of fertilisers plays an important role in agricultural development. Therefore, securing future of fertiliser is crucial to feed the ever-growing population of the world and India is no exception. Continuation of geo-political tensions in West Asia has disrupted the supply of global energy, fertilisers/raw materials/intermediates/feedstocks, etc. Proactive strategies of the Government of India in tandem with fertiliser industry have been helping to mitigate the adverse effect of major disruptions.

India navigates an increasing complex global fertiliser landscape. Reducing import dependency has become the top priority. The need is to expand domestic production, diversification of resources, adopt green technology, strengthen soil health by integrated nutrient management, enhance operational efficiency at every stage of supply-chain to ensure fertiliser, food and nutritional security on sustainable basis. Therefore, future lies in synergy of conventional and innovative fertilisers for sustainable agriculture. Further, south-west-monsoon may be disrupted due to severity of El-Niño. Government of India in collaboration with State Governments have been formulating contingency plan to mitigate the adverse effect of El-Niño.

This year's FAI Seminar is 62nd in the series with the theme of **Securing Fertiliser Future for Sustainable Agriculture**. It will provide an opportunity to take stock of the areas related to production, logistics, marketing and innovative fertiliser products and extension services to ensure food security. Further, appropriate policy interventions for nutrient security will also be deliberated.

The Seminar is scheduled during **26-28 November 2026** at Hotel Pullman & Novotel, Aerocity, New Delhi, India. As in the past, we are confident that all concerned will respond with full enthusiasm by sponsoring large number of delegates to make this unique fertiliser sector event successful and meaningful.

□ Securing Fertiliser Future for Sustainable Agriculture

Fertilisers are indispensable for agricultural growth, because they are plant food and meet the nutrient demand of the crop. The testimony of fact is that due to increased use of fertilisers from mere 65,600 MT in 1951-52 to 33.5 million MT in 2025-26, foodgrain production showed an increase from 52 million MT to 376 million MT during the period. There has been momentum growth in production of horticultural, cash and oilseed crops also. The pace of growth has to be kept up to meet the demand of burgeoning population in terms of food, feed, fuel and fibre. Therefore, growth in fertiliser is crucial to sustain growth in agriculture.

Many challenges in agriculture and fertiliser sectors are cropping up. In agriculture, these comprise of climate change; depletion of natural and water resources; fragmentation of land holdings; decline in soil health, soil organic carbon and crop response to fertiliser application due to imbalance in use; etc. In the case of fertilisers, India is import dependent to a great extent either in the form of finish products or raw materials/intermediates/feedstock being used in production of fertilisers. Geo-political conflicts hamper the supply of these commodities. Meticulous planning is in place to make fertilisers available to farmers. Realising the need to reduce import dependency, the fertiliser industry is promoting alternate fertilisers such as organic-, bio-, nano- fertilisers and other innovative fertiliser products along with traditional fertilisers to improve soil health and minimize environmental footprints. Advance technologies are also being given impetus. Conducive policy will go a long way to promote better use of fertilisers among the farmers. For long-term energy security, various initiatives by the Government are underway to promote coal gasification, green hydrogen and green ammonia. Existing plants are further exploring technology to enhance energy efficiency, improve reliability and integrate renewable energy into production process.

Unique feature of this year Seminar will be Panel Discussions followed by every technical session that precisely elaborate the practical aspects leading to tangible outcome.

It is in this context of above discussion, the experiences of the experts from India and abroad in the FAI Annual Seminar 2026 will be beneficial to all the delegates, to derive the blueprints on topical theme of **Securing Fertiliser Future for Sustainable Agriculture.**
