The programme is aimed to give exposure to practical as well as theoretical aspects of port handling operations of fertilizers/ raw materials/ intermediates, etc. It is also planned to take the participants to the port to show the activities being undertaken during the handling of imported materials and other logistics operations at the port.

Faculty for the programme will constitute of senior officials from the government, port, General Insurance Company, Stevedoring and Handling Agencies and the Subject Matter Specialists. The programme topics, registration form and other details are given in the programme brochure.

India is import dependent to a great extent to meet the demand of finished fertilizer products and raw materials and intermediates. Knowledge of logistics of import of fertilizers, raw materials and intermediates with regard to shipping assumes great importance in decision making in import activities. To give boost to movement of fertilizers through coastal shipping/inland waterways, Government of India has also notified policy for reimbursement of freight for movement of fertilizers by such mode. National Logistics Policy recently introduced by the Government of India is going to be a game changer in the fertilizer sector. Accordingly, the programme has been designed to give an exposure to the participants of the international market scenario for finished fertilizer commodities and various logistic activities in the process including coastal shipping. India also imports various fertilizers from UAE and Saudi Arabia and hence the programme being organized in Dubai assumes special significance.

It is in this context that FAI is organizing a programme on the subject 'Fertilizer Logistics, Port Handling Operations and Coastal Shipping' during March 13-16, 2023 at Hotel Grand Excelsior, Dubai.

The programme is designed in such a way so that the participants have both theoretical and practical exposure on this topical subject.
